NOTICE OF PROPOSED
2020-2024 CONSOLIDATED PLAN-2024 ACTION PLAN
and PUBLIC HEARINGS**

Pursuant to the provision of 24 CFR Part 91.105(b), the City of Henderson, Kentucky hereby notifies citizens, public agencies, and other interested parties of the availability for review of the proposed F.Y. 2024 *Action Plan*. The 2024-2025 *Action Plan* describes the federal resources which the City proposes to expend to address the priority needs and specific objectives identified in the 2020-2024 *Consolidated Plan-Action Plan*. The purpose of the 2024-2025 *Action Plan* is to state the City of Henderson's plans pursuant to the goals of providing decent housing and a suitable living environment and expanding economic opportunities principally for low- and moderate-income persons. The City expects to receive approximately \$250,239.00 (plus or minus) in Community Development Block Grant (C.D.B.G.) funds for the fiscal year beginning July 1, 2024. Proposed projects funding amounts may change should the 2024 CDBG Entitlement Grant be increased or decreased pending release of HUD's 2024 funding allocation notice. At least 70% of these funds will be expended for the benefit of low- and moderate-income persons. Information on the range of activities which may be undertaken with C.D.B.G. funds will be provided by contacting the City of Henderson Community Development Department. The proposed Plan will be available for review at the Henderson County Public Library at 101 South Main Street, the Housing Authority at 111 South Adams, and the office of the Community Development Department, 1990 Barret Court, Suite B, of the Peabody Building. The City will hold several public hearings at different times to allow citizens to review and comment on the 2020-2024 *Consolidated Plan-2024 Action Plan*. Public hearings will be on **Monday, April 29 at 1:30 a.m. and 6:30 p.m.**, in the Codes/Community Development Conference Room of the **Peabody Building**, 1990 Barret Court, Suite B, Henderson, Kentucky and at the **John F. Kennedy Community Center**, 515 South Alvasia Street, Henderson, Kentucky on **Tuesday, April 30 at 1:30 p.m. and 6:30 p.m.**

The meeting rooms in the City of Henderson Peabody Building/John F. Kennedy are accessible to the disabled.
