

**NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND
NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS**

These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by The City of Henderson.

REQUEST FOR RELEASE OF FUNDS

On or about August 13, 2025 the City of Henderson will submit a request to the United States Department for Housing and Urban Development (HUD) for the release of Community Development Block Grant funds under CDBG - Title 1 of the Housing and Community Development Act of 1974 (PL 93-383) as amended,) to undertake construction of new 5-foot-wide sidewalk starting on east side of Arrow Way approximately 95 linear south of intersection of Fair Street/Fairground Lane/Arrow Way continuing along the east side of Arrow Way then Fairground Lane to the southeast corner of the of intersection with Sand Lane (KY136) at an existing sidewalk. Continuing from northwest corner of the intersection of Sand Lane (KY136) and S. Alves Street with a 5-1/2-foot-wide sidewalk with header curb and connecting to an existing 5-1/2-foot-wide sidewalk with a header curb approximately 126+ feet along west side of S. Alves. The total cost is estimated to be approximately \$381,296.75 with \$381,296.75 in CDBG funds.

FINDING OF NO SIGNIFICANT IMPACT

The City of Henderson has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement (EIS) under the National Environmental Policy Act of 1969 (NEPA) is not required.

The City of Henderson has completed an Environmental Assessment (EA) respecting the project, which sets forth the reasons why such Statement is not required. This assessment is on file at the Henderson Municipal Building (222 First Street, Henderson KY 42420) and is available for public examination and copying, upon request at between the hours of 8am-5pm or at <https://www.hendersonky.gov>.

No further environmental review of the project is proposed to be conducted.

PUBLIC COMMENTS

All such comments received will be considered prior to authorizing submission of a request for a release of funds or taking any administrative action on the within project prior to the date specified on the proceeding sentence. Comments should specify which notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The City of Henderson will undertake the project described above with funds from HUD under (CDBG - Title 1 of the Housing and Community Development Act of 1974 (PL 93-383) as amended). The City of Henderson certifies to HUD that Bradley S. Staton in his capacity as Mayor consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review, decision making, and action; and that these responsibilities have been satisfied.

The legal effect of the certification is that upon its approval, the City of Henderson may use the funds and HUD will have satisfied its responsibilities under NEPA and related laws and authorities.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the The City of Henderson certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the The City of Henderson; (b) the City of Henderson has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the U.S. Department of HUD; Community Planning and Development; 601 W. Broadway; Ste. 110; Louisville, KY 40202 or via email at LouisvilleRROF@hud.gov. Potential objectors should contact HUD to verify the actual last day of the objection period.
